### POLICY NAME: DENTAL HEALTH

#### POLICY STATEMENT

We aim to promote children's general wellbeing by creating an environment that supports healthy dental and oral health habits and practices that can be maintained throughout the child's life. We will actively support and promote dental health and hygiene practices by advocating for healthy choices while reflecting practices through curriculum and role modelling.

#### BACKGROUND

Early childhood is an important time for developing good dental hygiene practices. From the time a baby starts teething, keeping gums and teeth clean can safeguard against cavities in the 'baby' teeth which can also cause damage to the permanent teeth underneath. Our services promote the importance of good dental health to children and families.

#### OVERALL STRATEGIES/HOW WILL IT BE DONE?

We believe that it is important for all children to practice a high level of dental hygiene and to minimise the risk of cavities forming we encourage children to eat nutritious foods and to limit sugary foods and drinks. These messages are also reflected in the food and drinks that we serve at our service and are embedded into our programs (see Nutrition and Food Safety Policy).

Educators act as role models to our children while at the service and are mindful of making healthy choices when eating and drinking in front of the children. Educators also use meal times as an opportunity to initiate discussions with children regarding positive choices and practices which support dental health and hygiene.

#### ROLES AND RESPONSIBILITIES

##### THE APPROVED PROVIDER/NOMINATED SUPERVISORS WILL:

- Ensure that obligations under the Education and Care Services National Law and National Regulations are met.
- Ensure all staff (including casual staff) receive information and induction training to fulfil their roles effectively, including being made aware of the Dental Health Policy, their responsibilities in implementing it, and any changes that are made over time.
- Ensure students, visitors and volunteers have knowledge of and adhere to this policy.
- Ensure that the daily menu contains a nutritional balance of foods including fresh fruit.
- Minimise the provision of sugary foods.
- Ensure access to safe drinking water at all times.
- Provide dental health information to parents and families in the form of newsletters, posters, web links etc.
- When possible, arrange visits by dental health professionals as part of the program. Families and children will be encouraged to attend these visits where children's teeth will be checked and correct brushing techniques and dental care will be discussed.

##### EDUCATORS WILL:

- Find opportunities to discuss dental health education and food and drink choices to support dental health with children as part of the program.
- Ensure dental health resources including posters, books and play resources will be provided for children as part of the program.
- Endeavour to offer children a chunk of cheese after each meal.
- Give children bottles before they go to bed as when children take a bottle to bed it allows the lactose (sugar) in the milk to sit on their teeth which can cause tooth decay.
- Encourage children to drink from a cup and encourage parents to replace bottles with the use of trainer cups.
- Role model healthy practices while at the service.

#### CONTINUOUS IMPROVEMENT/REFLECTION

Our Dental Health Policy will be reviewed annually, or earlier if there are changes to legislation, ACECQA guidance, or any incidents related to the policy. This review will be conducted in consultation with children, families, and staff.
